

Conference of Election Management Bodies of SAARC Member States

Islamabad, September 8-9, 2011

Conference Report

Introduction

The 2-day Conference of Election Management Bodies (EMBs) of SAARC Member States was held in Islamabad on 8-9 September 2011. The Election Commission of Pakistan in collaboration with United Nations Development Programme (UNDP) organized the event, second in the series of moots on the subject. The maiden conference of SAARC EMBs was convened in Dhaka on May 29-30, 2010 to share knowledge on electoral issues of the region. That meeting had concluded with a strong commitment from all the delegations to continue to meet and progress towards the formation of a Forum of Election Commissions of SAARC Member States.

The conferences on the overarching theme of electoral reforms are being organized in a regional scenario when all the SAARC Member States have democratic governments. Though Pakistan during its national history saw interludes of democratic governments, the current democratic dispensation that began in 2008 is sustaining. The South Asian governments now hold elections for their national parliaments, representative bodies, and local governments and find themselves on a learning curve in regard to various issues related to electoral and legislative reforms, as well as election procedures. In this backdrop, the second conference held in Islamabad had added significance as it dealt with a range of key aspects of electoral processes. The event highlighted the importance of electoral process for strengthening democracy, governance, and ensuring sustainable, political stability. It was a useful occasion to share experiences and learn from best practices through the conduct of elections at various levels.

A centerpiece achievement of the conference was the adoption of a resolution for the establishment of a Forum of SAARC Election Management Bodies. The first EMBs conference in Dhaka had deliberated on a draft Charter for the proposed forum. Bhutan had presented the proposal to set up the Forum at the 37th session of the Standing Committee of SAARC held in Thimphu in April 2010. Once established the Forum will promote mutual contact and learning for enhancing capabilities of the election bodies of the Member States towards conducting free and fair elections. It will also highlight democratic experiences of the region on the international scene, apart from working as a regional focal point for interacting with its counterpart organizations around the world.

Conference Objectives

The conference had the following objectives in view:

- Exchange of views on electoral experiences in the SAARC region with a view to learn from each other for making electoral processes more transparent and efficient
- Cooperation among the Member States in developing the capabilities of the EMBs to ensure free, fair and credible elections
 - Promotion of contacts and networking among the EMBs of the SAARC Member States
 - To discuss the possibility of making a permanent Election Management Bodies Forum under SAARC Secretariat
 - To keep the discussion rolling to finalize the Charter for EMB Forum, as it
 will help establish the entity as a formal body with clear lines of action

Highlights of the Conference Activities

The conference, which lasted for two days, had four sessions in which the participants presented insightful papers and made informative presentations on a wide range of themes including electoral justice, electoral legislation, on a wide resolution, reforms, election financing, capacity-building, dispute resolution, reforms, election financing, capacity-building, accountability, transparency, delimitation, voter registration, and role of accountability, transparency, delimitation, voter registration, and role of observers. Delegates of the member countries included Chief Election Commissioners along with other senior officials of the respective EMBs, Commissioners along with other senior officials of the respective EMBs, officials of the SAARC Secretariat, Kathmandu, officers of Ministries of officials and Interior of Pakistan, and representatives of UNDP Islamabad and International Foundation for Electoral Systems. A broad array of politicians from various political parties and Islamabad-based diplomats also attended the event.

The Member States, by adopting a resolution, agreed to establish a permanent Forum of SAARC Election Management Bodies to foster cooperation and share electoral experiences. Towards this objective, the conference endorsed the draft Charter which after receiving inputs from the Member States will be sent to SAARC Secretariat in Kathmandu.
